INTRODUCTION

- The 2021 ICD-10-CM Update includes
 - 490 New Codes
 - 47 Revised codes
 - 58 Deleted codes

TIMEFRAME FOR USE

- These 2021 ICD-10-CM codes from October 1, 2020 through September 30, 2021

*The 2021 codes will be effective for claims with "From" dates on or after October 1, 2020.

ICD-10-CM OFFICIAL GUIDELINES

- The guidelines are rules to accompany the conventions and instructions within the ICD-10-CM
- Instructions and conventions take precedence over guidelines
- Guidelines are based on the coding and sequencing instructions in the Tabular List and Alphabetic Index, and they provide additional instruction
- Adherence to the guidelines is required under the Health Insurance Portability and Accountability Act (HIPAA)
- The diagnosis codes have been adopted under HIPAA for all healthcare settings

ICD-10-CM OFFICIAL GUIDELINES

- A joint effort between the physician and the coder is essential for complete and accurate documentation and code assignment
- Consistent, complete documentation in the medical record is crucial
- Without this documentation coding will not be accurate
- The entire record should be reviewed to determine the reason for the encounter and the conditions being treated

CODING GUIDELINES – EXCLUDES 1 & 2 NOTES

- Excludes 1 is a pure excludes note and means "NOT CODED HERE".
- An exception to an Excludes 1 definition is the circumstance when the two conditions are *unrelated to each other*.
- Excludes 2 note represents "Not included here."
- An excludes 2 note indicates that the condition excluded is not part of the condition represented by the code, but a patient may have both conditions at the same time.
- When an excludes 2 note appears under a code it is acceptable to use both the code and the excluded code together when appropriate.

- **A84.8** - Other tick borne-viral encephalitis, is expanded to include 2 more specific codes
 - Louping ill
 - Powassan Virus Disease
 - The more specific codes are:
 - **A84.81** - Powassan Virus Disease
 - **A84.89** - Other tick-borne viral encephalitis

CHAPTER 1- CERTAIN INFECTIOUS & PARASITIC DISEASES

- **B34.2** Coronavirus infection, unspecified
 - New Excludes 1: COVID-19 (U07.1)

We will discuss U07.1 in detail when we get to chapter 22

CHAPTER 1- CERTAIN INFECTIOUS & PARASITIC DISEASES

- Helmanthiases
- The **B60.0** code for Babesiosis is expanded to include with specific types of Babesiosis below:
 - **B60.00** - Babesiosis, unspecified
 - **B60.01** - Babesiosis due to Babesia microti
 - **B60.02** - Babesiosis due to Babesia duncani
 - **B60.03** - Babesiosis due to Babesia divergens
 - **B60.09** - Other babesiosis

CHAPTER 3 - DISEASES OF BLOOD & BLOOD FORMING ORGANS & IMMUNE SYSTEM

- **D55.2** Anemia due to disorders of glycolytic enzymes
 - Excludes 1:
 - Revise from: disorders of glycolysis not associated with anemia (E74.8)
 - Revise to: disorders of glycolysis not associates with anemia (E74.81-)

CHAPTER 3 - DISEASES OF BLOOD & BLOOD FORMING ORGANS & IMMUNE SYSTEM

- Sickle Cell coding changes
- There are 4 New codes in the **D57-** Sickle Cell Disorders category:
 - **D57.03** - Hb-SS disease with cerebral vascular involvement
 - **D57.09** - Hb-SS disease with crisis with other specified complication
 - **D57.213** - Sickle-cell/Hb-C disease with cerebral vascular involvement
 - **D57.218** - Sickle-cell/Hb-C disease with crisis with other specified complication
- There were previously no codes for cerebral vascular problems related to sickle cell.

CHAPTER 3 - DISEASES OF BLOOD & BLOOD FORMING ORGANS & IMMUNE SYSTEM

- Several New more specific codes were added to categories **D57.4**-thalassemia disorders and **D57.8**- other sickle cell disorders:
 - **D57.413** - Sickle-cell thalassemia, unspecified, with cerebral vascular involvement
 - **D57.418** - Sickle-cell thalassemia, unspecified, with crisis with other specified complication
 - **D57.42** - Sickle-cell thalassemia beta zero without crisis
 - **D57.431** - Sickle-cell thalassemia beta zero with acute chest syndrome
 - **D57.432** - Sickle-cell thalassemia beta zero with splenic sequestration
 - **D57.433** - Sickle-cell thalassemia beta zero with cerebral vascular involvement

 - **D57.439** - Sickle-cell thalassemia beta zero with crisis, unspecified

 - Added to Excludes 2:
 - Evans syndrome (D69.41)
 - Hemolytic disease of newborn (P55.-)
 - Paroxysmal cold hemoglobinuria (D59.6)

- The **D59.1** code for Other autoimmune hemolytic anemias has been expanded to include the more specific codes below:

- The **D72.1** code for Eosinophilia is expanded to include the more specific codes below:

 - **D72.111** - Lymphocytic Variant Hypereosinophilic Syndrome [LHES]
 - **D72.118** - Other hypereosinophilic syndrome
 - **D72.119** - Hypereosinophilic syndrome [HES], unspecified
 - **D72.12** - Drug rash with eosinophilia and systemic symptoms syndrome
 - **D72.18** - Eosinophilia in diseases classified elsewhere
 - **D72.19** - Other eosinophilia

- IMMUNE DISORDERS
- **D84.8** - Other specified immunodeficiencies is expanded to include the more specific codes:

 - **D84.822** - Immunodeficiency due to external causes
 - **D84.89** - Other immunodeficiencies

- IMMUNE DISORDERS
- 6 New Codes - Other disorders involving the immune mechanism, not elsewhere classified:

 - **D89.834** - Cytokine release syndrome, grade 4

- The following metabolic codes are added for increased specificity:
 - The **E70.8** code, Other disorders of aromatic amino-acid metabolism, is expanded to include the more specific codes below:
 - **E70.81** - Aromatic L-amino acid decarboxylase deficiency
 - **E70.89** - Other disorders of aromatic amino-acid metabolism

CHAPTER 4 - ENDOCRINE, NUTRITIONAL & METABOLIC DISEASES

- The **E74.8** code, Other specified disorders of carbohydrate metabolism, is expanded to include the more specific codes below:
 - **E74.810** - Glucose transporter protein type 1 deficiency
 - **E74.818** - Other disorders of glucose transport
 - **E74.819** - Disorders of glucose transport, unspecified
 - **E74.89** - Other specified disorders of carbohydrate metabolism

CHAPTER 4 - ENDOCRINE, NUTRITIONAL & METABOLIC DISEASES

- **E86** – Volume Depletion
 - Deleted from Excludes 1:
 - Hypovolemic shock NOS (R57.1)
 - Added to Excludes 2:
 - Hypovolemic shock NOS (R57.1)
- **E88.0** – Disorders of plasma-protein metabolism, not elsewhere classified
 - Deleted from Excludes 1:
 - Disorder of lipoprotein metabolism (E78.-)
 - Added to Excludes 2:
 - Disorder of lipoprotein metabolism (E78.-)

CHAPTER 4 - ENDOCRINE, NUTRITIONAL & METABOLIC DISEASES GUIDELINES

- Edits to the guidelines for this chapter include instruction regarding coding use of non-insulin injectables to treat diabetes.
- If the patient is treated with both insulin and an injectable non-insulin antidiabetic drug, assign codes Z79.4, Long-term (current) use of insulin, and Z79.899, Other long term (current) drug therapy.
- If the patient is treated with both oral hypoglycemic drugs and an injectable non-insulin antidiabetic drug, assign codes Z79.84, Long-term (current) use of oral hypoglycemic drugs, and Z79.899, Other long-term (current) drug therapy.

CHAPTER 4 - ENDOCRINE, NUTRITIONAL & METABOLIC DISEASES GUIDELINES

- Some of the Non-insulin Injectable medications coded to **Z79.899** include:
 - Exenatide (Byetta)
 - Exenatide Extended Release (Bydureon)
 - Liraglutide (Victoza)
 - Dulaglutide (Trulicity)
 - Albiglutide (Tanzeum)
 - Pramlintide (Symlin)
- These drugs generally act to keep food in the stomach longer, increase insulin when you eat, and lowers the amount of glucose released by the liver.

CHAPTER 5 - MENTAL, BEHAVIORAL, NEURODEVELOPMENTAL DISORDERS

- 21 New codes have been added to Chapter 5 for withdrawal of substances including alcohol and opioids as well as other substances
 - **F10.130** - Alcohol abuse with withdrawal, uncomplicated
 - **F10.131** - Alcohol abuse with withdrawal delirium
 - **F10.132** - Alcohol abuse with withdrawal with perceptual disturbance
 - **F10.139** - Alcohol abuse with withdrawal, unspecified
 - **F10.930** - Alcohol use, unspecified with withdrawal, uncomplicated
 - **F10.931** - Alcohol use, unspecified with withdrawal delirium
 - **F10.932** - Alcohol use, unspecified with withdrawal with perceptual disturbance
 - **F10.939** - Alcohol use, unspecified with withdrawal, unspecified
 - **F11.13** - Opioid abuse with withdrawal
 - **F12.13** - Cannabis abuse with withdrawal

CHAPTER 5 - MENTAL, BEHAVIORAL, NEURODEVELOPMENTAL DISORDERS

- **F13.130** - Sedative, hypnotic or anxiolytic abuse with withdrawal, uncomplicated
- **F13.131** - Sedative, hypnotic or anxiolytic abuse with withdrawal delirium
- **F13.132** - Sedative, hypnotic or anxiolytic abuse with withdrawal with perceptual disturbance
- **F13.139** - Sedative, hypnotic or anxiolytic abuse with withdrawal, unspecified
- **F14.13** - Cocaine abuse, unspecified with withdrawal
- **F14.93** - Cocaine use, unspecified with withdrawal
- **F15.13** - Other stimulant abuse with withdrawal
- **F19.130** - Other psychoactive substance abuse with withdrawal, uncomplicated
- **F19.131** - Other psychoactive substance abuse with withdrawal delirium
- **F19.132** - Other psychoactive substance abuse with withdrawal with perceptual disturbance
- **F19.139** - Other psychoactive substance abuse with withdrawal, unspecified

CHAPTER 5 - GUIDELINE REVISIONS

- Revisions to the guidelines are bolded below.
- Mental and behavioral disorders due to psychoactive substance use
- Psychoactive Substance Use, Unspecified:
- The codes for unspecified psychoactive substance use (F10.9-, F11.9-, F12.9-, F13.9-, F14.9-, F15.9-, F16.9-, F18.9-, F19.9-) should only be assigned based on provider documentation and when they meet the definition of a reportable diagnosis.
- These codes are to be used only when the psychoactive substance use is associated with a **physical disorder included in chapter 5 (such as sexual dysfunction and sleep disorder)**, or a mental or behavioral disorder, and such a relationship is documented by the provider.

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- 24 more specific codes have been added to this chapter
- **G11.1** - Early-onset cerebellar ataxia now requires a 5th digit as noted in the 3 NEW codes below:
 - **G11.10** - Early-onset cerebellar ataxia, unspecified
 - **G11.11** - Friedreich ataxia
 - **G11.19** - Other early-onset cerebellar ataxia

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G20** Parkinson's disease – etiology/manifestation instructional note has been added
 - Use additional code to identify
 - Dementia with behavioral disturbance (F02.81)
 - Dementia without behavioral disturbance (F02.80)
- Other generalized epilepsy and epileptic syndromes added the NEW code below:
 - **G40.42** - Cyclin-Dependent Kinase-Like 5 Deficiency Disorder

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G40.8** Other epilepsy and recurrent seizures added the NEW codes below:
 - **G40.833** - Dravet syndrome, intractable, with status epilepticus-
 - **G40.834** - Dravet syndrome, intractable, without status epilepticus
- **G44.8** Other specified headache syndromes
 - Added Excludes 2:
 - headache with orthostatic or positional component, not elsewhere classified (R51.0)

- **G71.2** Congenital myopathies
 - Deleted Excludes 1:
 - arthrogryposis multiplex congenita (Q74.3)
 - Added Excludes 2:

- **G71.2** Congenital myopathies was expanded to include the following 5 NEW more specific codes:
 - **G71.20** - Congenital myopathy, unspecified
 - **G71.21** - Nemaline myopathy

 - **G71.228** - Other centronuclear myopathy
 - **G71.29** - Other congenital myopathy

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G93.2** Benign intracranial hypertension
 - Add Excludes 1:
 - Obstructive hydrocephalus (G91.1)
- **G93.4** Other and unspecified encephalopathy
 - Delete Excludes 1:
 - Toxic (metabolic) encephalopathy (G92)
 - Add Excludes 2:
 - Toxic (metabolic) encephalopathy (G92)

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G96.0** Cerebrospinal fluid leak, is expanded to include the following 5 NEW more specific codes:
 - **G96.00** - Cerebrospinal fluid leak, unspecified
 - **G96.01** - Cranial cerebrospinal fluid leak, spontaneous
 - **G96.02** - Spinal cerebrospinal fluid leak, spontaneous
 - **G96.08** - Other cranial cerebrospinal fluid leak
 - **G96.09** - Other spinal cerebrospinal fluid leak
- **G96.19** Other disorders of meninges, not elsewhere classified is expanded to include the following 2 NEW codes:
 - **G96.191** - Perineural cyst
 - **G96.198** - Other disorders of meninges, not elsewhere classified

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G96.8** Other specified disorders of central nervous system is expanded to include the following 4 codes:
 - **G96.810** - Intracranial hypotension, unspecified
 - **G96.811** - Intracranial hypotension, spontaneous
 - **G96.819** - Other intracranial hypotension
 - **G96.89** - Other specified disorders of central nervous system

CHAPTER 6 - DISEASES OF THE NERVOUS SYSTEM

- **G97.8** Other intraoperative and postprocedural complications and disorders of nervous system is expanded to include the following 2 codes:
 - **G97.83** - Intracranial hypotension following lumbar cerebrospinal fluid shunting
 - **G97.84** - Intracranial hypotension following other procedure

CHAPTER 7 - DISEASES OF THE EYE

- More specific codes have been added to include a 6th digit requirement to indicate laterality
- **H18.50** Unspecified hereditary corneal dystrophies, is expanded to include 4 codes to indicate laterality:
 - **H18.501** - Unspecified hereditary corneal dystrophies, right eye
 - **H18.502** - Unspecified hereditary corneal dystrophies, left eye
 - **H18.503** - Unspecified hereditary corneal dystrophies, bilateral
 - **H18.509** - Unspecified hereditary corneal dystrophies, unspecified eye

CHAPTER 7 - DISEASES OF THE EYE

- The code **H18.51** Endothelial corneal dystrophy is expanded to 4 codes to indicate laterality:
 - **H18.511** - Endothelial corneal dystrophy, right eye
 - **H18.512** - Endothelial corneal dystrophy, left eye
 - **H18.513** - Endothelial corneal dystrophy, bilateral
 - **H18.519** - Endothelial corneal dystrophy, unspecified eye

- The code **H18.52** Epithelial (juvenile) corneal dystrophy is expanded to 4 codes to indicate laterality:
 - **H18.521** - Epithelial (juvenile) corneal dystrophy, right eye
 - **H18.522** - Epithelial (juvenile) corneal dystrophy, left eye
 - **H18.523** - Epithelial (juvenile) corneal dystrophy, bilateral
 - **H18.529** - Epithelial (juvenile) corneal dystrophy, unspecified eye

CHAPTER 7 - DISEASES OF THE EYE

- The code **H18.53** Granular corneal dystrophy is expanded to include 4 codes indicating laterality:
 - **H18.531** - Granular corneal dystrophy, right eye
 - **H18.532** - Granular corneal dystrophy, left eye
 - **H18.533** - Granular corneal dystrophy, bilateral
 - **H18.539** - Granular corneal dystrophy, unspecified eye

- The code **H18.54** Lattice corneal dystrophy is expanded to include 4 codes indicating laterality:
 - **H18.541** - Lattice corneal dystrophy, right eye
 - **H18.542** - Lattice corneal dystrophy, left eye
 - **H18.543** - Lattice corneal dystrophy, bilateral
 - **H18.549** - Lattice corneal dystrophy, unspecified eye

CHAPTER 7 - DISEASES OF THE EYE

- The code **H18.55** Macular corneal dystrophy is expanded to include the following codes indicating laterality:
 - **H18.551** - Macular corneal dystrophy, right eye
 - **H18.552** - Macular corneal dystrophy, left eye
 - **H18.553** - Macular corneal dystrophy, bilateral
 - **H18.559** - Macular corneal dystrophy, unspecified eye
- The code **H18.59** Other hereditary corneal dystrophies is expanded to include the following codes for laterality:
 - **H18.591** - Other hereditary corneal dystrophies, right eye
 - **H18.592** - Other hereditary corneal dystrophies, left eye
 - **H18.593** - Other hereditary corneal dystrophies, bilateral
 - **H18.599** - Other hereditary corneal dystrophies, unspecified eye

CHAPTER 7 - DISEASES OF THE EYE

- Revision to the description of code H55.81
 - From: **H55.81** - Saccadic eye movements
 - To: **H55.81** - Deficient saccadic eye movements
- NEW code in this chapter:
 - **H55.82** - Deficient smooth pursuit eye movements

NO CHANGES!

CHAPTER 9 - CIRCULATORY SYSTEM

- **I11 Hypertensive heart disease** - Includes note change
 - Revise from: any condition in I50.-, I51.4-I51.9 due to hypertension
 - Revise to: any condition in I50.-, I51.4-I51.7, I51.89, I51.9 due to hypertension
 - (I51.81 Takotsubo syndrome is no longer included)

CHAPTER 9 - CIRCULATORY SYSTEM

- **I70.- Atherosclerosis**
 - Several includes notes have been added to the content of this category for Atherosclerosis of the extremities
- **Examples:**
 - **I70.2 Atherosclerosis of native arteries of the extremities**
 - **I70.22 Atherosclerosis of native arteries of the extremities with rest pain**
 - **Added Includes:**
 - chronic limb-threatening ischemia NOS of native arteries of extremities
 - chronic limb-threatening ischemia of native arteries of extremities with rest pain
 - critical limb ischemia NOS of native arteries of extremities
 - critical limb ischemia of native arteries of extremities with rest pain

I70.- ATHEROSCLEROSIS EXAMPLES - CONTINUED

- **I70.23 Atherosclerosis of native arteries of the extremities of right leg with ulceration**
 - **Add Includes:**
 - chronic limb-threatening ischemia of native arteries of right leg with ulceration
 - critical limb ischemia of native arteries of right leg with ulceration
- **I70.24 Atherosclerosis of native arteries of the extremities of left leg with ulceration**
 - **Add Includes:**
 - chronic limb-threatening ischemia of native arteries of left leg with ulceration
 - critical limb ischemia of native arteries of left leg with ulceration
- **I70.26 Atherosclerosis of native arteries of the extremities with gangrene**
 - **Add Includes:**
 - chronic limb-threatening ischemia of native arteries of extremities with gangrene
 - critical limb ischemia of native arteries of extremities with gangrene

CHAPTER 10 - DISEASES OF THE RESPIRATORY SYSTEM

- No changes to coding of COPD, asthma, or emphysema
- New codes for increased specificity for pulmonary eosinophilia & interstitial fibrosis conditions

CHAPTER 10 - DISEASES OF THE RESPIRATORY SYSTEM

- Code **J82** - Pulmonary eosinophilia, not elsewhere classified is expanded to include the following 4 codes:
 - **J82.81** - Chronic eosinophilic pneumonia
 - **J82.82** - Acute eosinophilic pneumonia
 - **J82.83** - Eosinophilic asthma
 - **J82.89** - Other pulmonary eosinophilia, not elsewhere classified
- Code **J84.17** - Other interstitial pulmonary diseases with fibrosis in diseases classified elsewhere is expanded to include the following 2 codes:
 - **J84.170** - Interstitial lung disease with progressive fibrotic phenotype in diseases classified elsewhere
 - **J84.178** - Other interstitial pulmonary diseases with fibrosis in diseases classified elsewhere

CHAPTER 10 - DISEASES OF THE RESPIRATORY SYSTEM

- The following J codes all add the same excludes 1 note:
 - **J00** Acute nasopharyngitis [common cold]
 - **J02.9** Acute pharyngitis, unspecified
 - **J03.9** Acute tonsillitis, unspecified
 - **J06** Acute upper respiratory infections of multiple and unspecified sites
 - Add Excludes 1: influenza virus with other respiratory manifestations (J09.X2, J10.1, J11.1)
- **J43** Emphysema
 - Delete Excludes 1: traumatic subcutaneous emphysema (T79.7)

- New guideline information for codes found in categories Z55- Z65, Persons with potential health hazards related to socioeconomic and psychosocial circumstances, code assignment may be based on medical record documentation from clinicians involved in the care of the patient who are not the patient's provider since this information represents social information, rather than medical diagnoses.
- **Patient self-reported documentation may also be used to assign codes for social determinants of health, as long as the patient self-reported information is signed-off by and incorporated into the health record by either a clinician or provider.**

CHAPTER 21 - FACTORS INFLUENCING HEALTH STATUS & CONTACT WITH HEALTH SERVICES

- The codes from Z55 to Z65 include domestic situations that have an affect on the patient's ability to progress with a plan of care and may be situations someone not in the home would not be aware of.
- For example:
 - **Z59.4**- Lack of adequate food and safe drinking water
 - **Z63.72** Alcoholism and drug addiction in family.

CHAPTER 22 - CODES FOR SPECIAL PURPOSES (U00-U85)

- This chapter has a reserved block of codes for special purposes. It includes a section for “Provisional assignment of new diseases of uncertain etiology or emergency use (U00-U49). Codes in this range are to be used by WHO for assignment of new diseases of uncertain etiology.
- These codes were implemented on April 1, 2020. Both of these codes if used as primary diagnosis will assign to the MMTA-Respiratory group in PDGM.
 - U07.0 Vaping-related disorder
 - U07.1 COVID-19

CHAPTER 22 - CODES FOR SPECIAL PURPOSES (U00-U85)

- WHO developed the vaping related disorder code last year due to the spike in injuries and illnesses related to use of e cigarettes and vaping materials.
- After WHO declared the COVID-19 pandemic, the implementation dates for these 2 codes were moved up from the original planned date of 10/1/2020 to April this year.

CHAPTER 22 – COVID-19

- The U07.1 code should only be reported for confirmed or presumed positive COVID-19 cases. Presumed is interpreted as confirmed.
 - A presumptive diagnosis is a patient that has been tested with results pending but is presumed to be positive
 - It does not have to be used as a primary diagnosis
 - Asymptomatic but positive patients are coded with U07.1
 - Coding guidelines require the U07.1 code precede associated manifestations such as pneumonia - J12.89

CHAPTER 22 – COVID-19

- The Z20.828 code- Contact with and (suspected) exposure to other viral communicable diseases is used for suspected but not confirmed Covid-19 cases.
 - A suspected (probable, inconclusive and possible) case is someone who has not been tested but has symptoms.
- Confirmation does not require documentation of a positive test result for COVID-19.
- The provider's documentation that the individual has COVID-19 is sufficient.

CHAPTER 22 – COVID-19

- If the provider documents "suspected," "possible," "probable," or "inconclusive" COVID-19, do not assign code U07.1. Instead, code the signs and symptoms reported.
- Sequencing of codes- When COVID-19 meets the definition of principal diagnosis, code U07.1, COVID-19, should be primary, followed by the codes for any manifestations, except when another guideline requires that other codes be sequenced first, such as sepsis, or transplant complications.
- For a COVID-19 infection in a lung transplant patient, see Section I.C.19.g.3.a. Transplant complications other than kidney.

CHAPTER 22 – COVID-19

- Acute respiratory manifestations of COVID-19:
 - When the reason for the encounter is a respiratory manifestation of COVID-19, assign code U07.1, COVID-19, as the principal diagnosis and assign codes for the respiratory manifestations as additional diagnoses.
- The following conditions are examples of common respiratory manifestations of COVID-19:
 - Pneumonia- For a patient with pneumonia confirmed as due to COVID-19, assign codes U07.1, COVID-19, and J12.89, Other viral pneumonia.

CHAPTER 22 – COVID-19

- Acute respiratory manifestations of COVID-19:
 - Acute bronchitis- For a patient with acute bronchitis confirmed as due to COVID-19, assign codes U07.1, and J20.8, Acute bronchitis due to other specified organisms.
 - Bronchitis not otherwise specified (NOS) due to COVID-19 should be coded using code U07.1 and J40, Bronchitis, not specified as acute or chronic.
 - Lower respiratory infection- If the COVID-19 is documented as associated with a lower respiratory infection, not otherwise specified (NOS), or an acute respiratory infection, NOS, codes U07.1 and J22, Unspecified acute lower respiratory infection, should be assigned.

CHAPTER 22 – COVID-19

- If the COVID-19 is documented as being associated with a respiratory infection, NOS, codes U07.1 and J98.8, Other specified respiratory disorders, should be assigned.
 - Acute respiratory distress syndrome- (ARDS) due to COVID-19, assign codes U07.1, and J80, Acute respiratory distress syndrome.
 - Acute respiratory failure due to COVID-19, assign code U07.1, and code J96.0-, Acute respiratory failure.

CHAPTER 22 – COVID-19

- Non-respiratory manifestations of COVID-19
- When the reason for the encounter/admission is a non-respiratory manifestation (e.g., viral enteritis) of COVID-19, assign code U07.1, COVID-19, as the principal/first-listed diagnosis and assign code(s) for the manifestation(s) as additional diagnoses.
- Exposure to COVID-19 For asymptomatic individuals with actual or suspected exposure to COVID-19, assign code Z20.828, Contact with and (suspected) exposure to other viral communicable diseases.

CHAPTER 22 – COVID-19

- For symptomatic individuals with actual or suspected exposure to COVID-19 and the infection has been ruled out, or test results are inconclusive or unknown, assign code Z20.828, Contact with and (suspected) exposure to other viral communicable diseases.
- See guideline I.C.21.c.1, Contact/Exposure, for additional guidance regarding the use of category Z20 codes. If COVID-19 is confirmed, see guideline I.C.1.g.1.a. (f) Screening for COVID-19 During the COVID-19 pandemic, a screening code is generally not appropriate.
- Coding guidance will be updated as new information concerning any changes in the pandemic status becomes available.

CHAPTER 22 – COVID-19

- Signs and symptoms without definitive diagnosis of COVID-19 (such as fever, etc.) but a definitive diagnosis has not been established, assign the appropriate codes for each of the presenting signs and symptoms such as:
 - R05 Cough
 - R06.02 Shortness of breath
 - R50.9 Fever, unspecified

CHAPTER 22 – COVID-19

- If a patient with signs/symptoms associated with COVID-19 also has an actual or suspected contact with or exposure to COVID-19, assign Z20.828, Contact with and (suspected) exposure to other viral communicable diseases, also.
- For asymptomatic individuals who test positive for COVID-19- Although the individual is asymptomatic, the individual has tested positive and is considered to have the COVID-19 infection.
- After COVID-19 infection has resolved- For individuals who previously had COVID-19 and COVID-19 test results are negative, assign code Z86.19, Personal history of other infectious and parasitic diseases.

CHAPTER 22 - VAPING RELATED DISORDERS

- Vaping-related disorders- assign code U07.0, can be the principal diagnosis. For lung injury due to vaping, assign only code U07.0.
- Assign additional codes for other manifestations, such as acute respiratory failure (subcategory J96.0-) or pneumonitis (code J68.0).
- Associated respiratory signs and symptoms due to vaping, such as cough, shortness of breath, etc., are not coded separately, when a definitive diagnosis has been established as these are considered inherent with lung injury.
- It would be appropriate to use any additional codes for gastrointestinal symptoms, such as diarrhea and abdominal pain.

CHAPTER 22 - VAPING RELATED DISORDERS

- For patients documented with electronic cigarette (e-cigarette), or vaping, product use associated lung injury (EVALI), assign the code for the specific condition, such as:
 - J68.0 Bronchitis and pneumonitis due to chemicals, gases, fumes and vapors; includes chemical pneumonitis
 - J69.1 Pneumonitis due to inhalation of oils and essences; includes lipoid pneumonia
 - J80 Acute respiratory distress syndrome
 - J82 Pulmonary eosinophilia, not elsewhere classified
 - J84.114 Acute interstitial pneumonitis
 - J84.89 Other specified interstitial pulmonary disease

CHAPTER 22 - VAPING RELATED DISORDERS

- For patients with acute lung injury but without further documentation identifying a specific condition (pneumonitis, bronchitis), assign code:
 - J68.9 Unspecified respiratory condition due to chemicals, gases, fumes, and vapors

CHAPTER 22 - VAPING RELATED DISORDERS

- Poisoning and toxicity - Acute nicotine exposure can be toxic. Children and adults have been poisoned by swallowing, breathing, or absorbing e-cigarette liquid through their skin or eyes. For these patients assign code:
 - T65.291- Toxic effect of other nicotine and tobacco, accidental (unintentional); includes toxic effect of other tobacco and nicotine NOS.
- For a patient with acute tetrahydrocannabinol (THC) toxicity, assign code:
 - T40.7X1- Poisoning by cannabis (derivatives), accidental (unintentional).

CHAPTER 22 - VAPING RELATED DISORDERS

- Pts with documented substance use/abuse/dependence, additional codes identifying the substance(s) used should be assigned.
- If documentation refers to use, abuse and dependence of the same substance (e.g. nicotine, cannabis, etc.), only one code should be assigned to identify the pattern of use based on the following hierarchy:
 - If both use and abuse are documented, assign only the code for abuse
 - If both abuse and dependence are documented, assign only the code for dependence
 - If use, abuse and dependence are all documented, assign only the code for dependence
 - If both use and dependence are documented, assign only the code for dependence.

CHAPTER 22 - VAPING RELATED DISORDERS

- Substance use, abuse, and dependence
- Assign as many codes, as appropriate. Examples:
 - Cannabis related disorders: F12.xxx
 - Nicotine related disorders: F17.xxx
- Specifically, for vaping of nicotine, assign code:
 - F17.29-, Nicotine dependence, other tobacco products. Electronic nicotine delivery systems (ENDS) are non-combustible tobacco products.

CHAPTER 22 - VAPING RELATED DISORDERS

- For patients presenting with any signs/symptoms where a definitive diagnosis has not been established, assign the appropriate code(s) for each of the presenting signs and symptoms such as:
 - M79.10 Myalgia, unspecified site
 - R06.00 Dyspnea, unspecified
 - R06.02 Shortness of breath
 - R06.2 Wheezing
 - R06.82 Tachypnea, not elsewhere classified
 - R07.9 Chest pain, unspecified
 - R09.02 Hypoxemia

CHAPTER 22 - VAPING RELATED DISORDERS

- For patients presenting with any signs/symptoms where a definitive diagnosis has not been established, assign the appropriate code(s) for each of the presenting signs and symptoms such as:
 - R09.89 Other specified S/S involving the circulatory & respiratory systems (includes chest congestion) R10.84 Generalized abdominal pain
 - R10.84 Generalized abdominal pain
 - R10.9 Unspecified abdominal pain
 - R11.10 Vomiting, unspecified
 - R11.11 Vomiting without nausea
 - R11.2 Nausea with vomiting, unspecified

CHAPTER 22 - VAPING RELATED DISORDERS

- For patients presenting with any signs/symptoms where a definitive diagnosis has not been established, assign the appropriate code(s) for each of the presenting signs and symptoms such as:
 - R19.7 Diarrhea, unspecified
 - R50.- Fever of other and unknown origin
 - R53.83 Other fatigue
 - R61 Generalized hyperhidrosis (night sweats)
 - R63.4 Abnormal weight loss
 - R68.83 Chills (without fever)

CONCLUSION

- These Codes are to be used for encounters beginning October 1, 2020 through September 30, 2021.
- The 2021 codes will be effective for claims with "From" dates on or after October 1, 2020.
- Coders need to become familiar with the FY 2021 code set and guidelines, so they are prepared to use them beginning October 1st!
